 - Trees are falling. Everything else to seems pretty good.
 - Dust control from Garrison Township sounds like it will be done by end of July.
 Garrison doesn't know if it even pays to do it now. Garrison Township spends a total of \$50,000 on dust control and this year it has been taking awhile to get it.
- 7. Ira Mowing Ira said it takes too long, he needs to get paid more. It takes him 3 hours to do it. Chris has no problem for \$30/hour. Chris makes a motion that we pay Ira \$30/hour to mow lawn, 2nd by Rick, all in favor, motion carried, Ann did not vote.
